Original Cards will only be returned if a stamp self addressed envelope is included with your entry. Cards not returned may be used by the promoter for marketing purposes. Recognition will be given to the creator.
2. The entry must use genuine Copic products. Each colour used must be identified by colour number on the entry form and the location of that colour must also be listed. The stamp, ink and card stock used must be listed on the entry to be eligible to win. Where Copic is used to colour embellishments, these must also be listed.
3. The original Card must be submitted for the entry to be valid. No computer generated images will be accepted.
4. Entries must be received at the specified address by 5:00pm on 3th June 2011.
5. One Design per entry can be submitted. Multiple entries are permitted, provided a separate form is completed,
